#### **DIRECTOR'S REPORT**

The 50 for 50 campaign accrued \$22,162 in donations for 2017. All donations received in 2017 total \$60,390. A GoFundMe page was created for Miller Park Library in the name of a young doctor who recently passed, which will focus on redesigning the youth area. These funds are not included in the above total.

There was a Public Records Request from WBNS for a copy of the Upper Arlington Public Library's Code of Conduct and record of evictions. The Library complied with the request for a copy of the Code of Conduct, but we do not maintain records of evictions.
